**ANNUAL VOTERS' MEETING
REDEEMER LUTHERAN CHURCH AND KINDERCOTTAGE PRESCHOOL
SUNDAY, DECEMBER 4, 2022
2:00 P.M.**

The Annual Voters' Meeting of Redeemer Lutheran Church was called to order at 2:00 P.M. on Sunday, December 4, 2022 by chairman Jim Arends.

Secretary Paula Schram affirmed that there was a quorum present. 50 members were present.

Opening devotions were given by Pastor Senstad taken from Romans 12, verses 4 and 5, and Galatians 5, verses 19–25. These verses remind us to show and share with others the fruit of the Spirit. Here at Redeemer we don't all have the same gifts, but we can show and share the fruit of the Spirit. We all have different talents and gifts given by God and we need to be willing to use these to serve along with others in our congregation.

The minutes of the Annual Meeting on December 5, 2021 were reviewed. **IT WAS MOVED BY GAYLE BOBOLZ AND SECONDED BY BOB NAYLOR TO APPROVE THESE MINUTES. MOTION CARRIED.**

Reports by Called Staff

Pastor Russell Senstad: The Synodical Convention will be held this summer in Milwaukee. Our circuit will not have a lay delegate to represent us, but we will have a pastor. It is our responsibility to nominate people to be on various boards within the synod. If you know any people who have been nominated, please let either of the pastors know. Our district continues to be doing well, but please continue to keep our district president Steve Turner in your prayers. Unfortunately, he has had to close some churches, and currently there are also some other churches who are struggling to hold on. Good news is there are some new churches being opened (Sudanese). Our circuit is made up of Sioux City, Lawton, Sergeant Bluff, and Climbing Hill. You have to have 1,500 people on your membership roster to form a circuit. Our circuit is blessed to belong to IDW. Here at Redeemer, we continue to place emphasis on getting people involved in at least one Bible study. It is difficult to get people to commit to this. We are currently looking into the Red Letters Bible study.

Pastor David Zirpel: Pastor was playing with the New Horizon Band and his report was given by Pastor Senstad. While statistics and numbers are discouraging for Christianity, it was noted how blessed our congregation is. We have had 18 infant baptisms, 2 adult baptisms, 7 adult confirmations, and 19 new households join our church. We have also conducted 13 funerals. This past month we raised over \$4,600 for the Luke Konkel Family. This year we raised over \$97,000 to help various organizations. With the help of other organizations, the St. Paul's golf outing raised \$26,000. We are busy doing various projects and funding is not a problem. As Christian churches we need to be united and join together to speak out against the WOKE culture that is supported by today's environment we live in. There are people out there who don't just respectfully disagree with conservative Christian values, but they want to cancel out our voices to be heard.

Thank you to Tara Van Meter who has been filling in while we continue our search for a new DCE. She noted that Sunday school and youth group is doing well.

DCE Search: The committee completed their search and interviewed four candidates for the position. They are all males with some previous experience. In January, we plan to invite them to Redeemer so we can get to know them better and show them around. The plan is to have all visits completed by the end of January, then continue with the call process.

The candidates were introduced. There were no nominations from the floor.

The budget for 2023 was introduced and Gerry gave some information on how various budget items regarding the pastors' salaries are figured. She also explained how insurance is figured. The budget being proposed would give our staff a three percent increase in their salaries. The budget information in the packet shows the 2022 re-estimate/ change/ 2023 proposed budget. Some questions were asked about the re-estimated budget, and why and how the budget was changed without voter approval. Gerry explained that the budget didn't change, but some corrections to the budget needed to be made. She explained that she discovered some discrepancies over how the pastors' salaries have been calculated in the past. She also explained that the pastors had overpaid for their insurance the past two years, and that this was corrected and the church paid back the money that was owed them. The Leadership Council also voted to spend \$10,000 more than was budgeted to fix the concrete by door 6, and the wall on the north side of the church. There were also some questions about the budget regarding advertising and publicity. It was noted that this year we went over budget on advertising so we want to increase that amount. It was discussed that possibly we could use Thrivent Dollars, or get help from the Endowment to help cover these costs. Questions were then addressed regarding the salaries according to the re-estimated budget. Gerry again explained that we paid them back for insurance we owed them. We did not increase the pastors' salaries. It was paid out of payable money that was deducted, but should not have been. In regards to their salaries, Gerry adjusted them but did not back pay them. There was also a discussion regarding the account that reimburses the pastors for mileage. It was stated that we are a business, and that normally salaries make up approximately 50% of the budget, but for this proposed budget salaries make up more than 75% of it. It was also noted that our congregation is getting older and there is concern whether our congregation will be able to continue to keep up with these pay increases. Someone brought up that we need to encourage people to participate in the endowment funds we have available. This would encourage forward progress with our operations. Members can visit with Jim Schroeder about this.

IT WAS MOVED BY LISA GOTTBURG AND SECONDED BY GERRY JUDD TO AMEND THE PROPOSED BUDGET FOR 2023 AND REESTABLISH THE LIBRARY BUDGET TO \$800. MOTION CARRIED.

IT WAS MOVED BY SCOTT ERNST AND SECONDED BY SHARI BENSON TO AMEND THE PROPOSED BUDGET FOR 2023 AND NOT HAVE AN INCREASE IN STAFF SALARIES. MOTION DID NOT PASS.

IT WAS MOVED BY MARY LYMAN AND SECONDED BY BOB NAYLOR TO APPROVE THE AMENDED PROPOSED BUDGET FOR 2023. MOTION CARRIED.

Sudanese Ministry – William from the Sudanese Worship Service came in and introduced himself to the congregation.

2023 Elder Report: Jeremy Schram was unable to attend so Woody Gottburg shared his report. The members of Redeemer Lutheran Church continue to be faithful in worship, service, and mission, remaining steadfast in Word and Lutheran doctrine. We continue to be blessed with so many faithful members who love to serve our Lord in many different ways. We continue to be concerned about the overall worship attendance by our members, as well as our Sunday School and youth program involvement numbers. Last spring, we held an Every Member Visitation event. Although there were some flaws in the execution of this task, there were many positives that came out of it. Some helpful ideas and suggestions were given regarding various topics. Shortly after this event we began live-streaming our services which is much appreciated by many. Last summer we spent some time working on updating our membership. We are currently in search of a new DCE. We plan on having some in-person visits with some candidates in January, so we are very much looking forward to meeting with them. Please pray that God will soon lead the right person to serve us in this ministry. We would like to extend a huge thanks to Tara Van Meter for helping with our youth programs. May God continue to bless the members of Redeemer Lutheran Church as we work together within the Holy Christian Church all throughout the world, spreading the good news of salvation made available by God's free gift of Grace through Faith in our Lord and Savior, Jesus Christ.

Endowment and Legacy Committee Report: Gale Bobolz shared a packet from the Endowment and Legacy Committee. The committee has been discussing the future of our congregation as we gain and lose members. We want to be able to maintain our status quo. An account has been established for our congregation. People may leave gifts while they are alive, or as part of their will to be established at their death. This account would help the operating budget of our congregation.
